CSIAMUN XVIII Privacy Policy

Consent to Collection and Use of Personal Information

The participant's personal information will be collected, used, and provided according to the Personal Information Protection Act to ensure the smooth operation of this conference and to protect against unauthorized collection, misuse, or abuse.

Legal Basis for Processing Personal Information:

- Personal information is collected and used within the necessary scope of the event's operation based on the participant's consent in accordance with **Article 15 (Collection and Use of Personal Information)** of the Personal Information Protection Act.
- Personal information will be destroyed immediately after the event in compliance with **Article 21 (Destruction of Personal Information)**.

Rights of the Information Subject:

- Participants have the right to access, correct, delete, stop processing, or request the destruction of their personal information in accordance with **Articles 4, 35 to 38** of the Personal Information Protection Act.
- In the event of damages caused by a violation of the Act, participants may claim compensation under **Article 39** of the Act.

Personal Information Collected:

- Information collected includes name, date of birth, address, email, phone number, school attended, and other necessary details for the event's operation.

Purpose of Collection and Use:

- Personal information is used for participant identification, verification of eligibility, participant roster management, and the generation of statistical data.
- When necessary, this information may be shared with the participant's school or related institutions.

Provision of Information:

- Collected personal information may be provided to relevant institutions, such as the participant's school, for eligibility verification and related purposes.

Retention and Use Period:

- Personal information will be retained and used only during the period necessary for the event and will be destroyed immediately after its conclusion.

Right to Refuse Consent:

- Participants may refuse to consent to the collection, use, and provision of their personal information. However, refusal may prevent the processing of their application and participation in the event.
